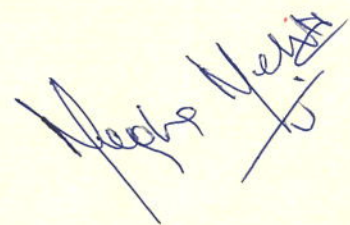

1. Amended and restated brand license agreement dated March 6, 2026 executed between MEMG International India Private Limited and the Company ("Restated Brand License Agreement")

Pursuant to the Restated Brand License Agreement, MEMG International (India) Private Limited ("Licensor") has granted the Company an exclusive, sub-licensable (in the ordinary course of their business), perpetual, non-

transferable, non-assignable license to the Company to use the  trademark ("Brand") set out in the Restated Brand License Agreement, solely in relation to, for the purposes of and in connection with its healthcare services business and hospital business (as defined in the Restated Brand License Agreement) ("Business") by itself or through its Subsidiaries throughout the world. The Company is required to pay a one-time capitalisation fee to the Licensor based on the value of the Brand as determined by a registered valuer ("Royalty") which was settled on March 12, 2026 by the issue and allotment of 23,820,811 Equity Shares of the Company aggregating to 2.02% of the issued and paid-up share capital of the Company to the Licensor.

The Restated Brand License Agreement cannot be terminated upon payment of Royalty.

The Company Brand License Agreements may be terminated either by mutual agreement between the parties in writing or upon expiry of the term unless the same is renewed by the parties.
