Overview

Dr. Prasanta Debnath is a Consultant in the Department of Medical Gastroenterology at Manipal Hospitals E.M. Bypass, Kolkata. With a robust academic foundation, he completed his MBBS from RIMS, Imphal/Manipur University (2008-2014), MD in General Medicine from UCMS, New Delhi/Delhi University (2014-2017), DM in Medical Gastroenterology from TNMC & BYL Nair Charitable Hospital, Mumbai/Maharashtra University of Health Sciences (2017-2020), and DrNB in Medical Gastroenterology at NBE (2021). Formerly an Assistant Professor in the Department of Gastroenterology at BYL nair hospital, mumbai, Dr. Debnath has extensive clinical and research experience. His investigative contributions include projects on predictive models for response to DAA in HCV cirrhosis, combined NS5A and NS5B inhibitors in chronic HCV with CKD on hemodialysis, comparison of VCTE versus serum biomarkers in chronic HCV, ASGE criteria's accuracy in choledocholithiasis prediction, and severity markers in acute pancreatitis. He has also explored H. pylori genotypes' impact on gastritis. Dr. Debnath's endoscopy expertise spans over various diagnostic upper GI endoscopies, colonoscopies, and a wide array of

therapeutic procedures, including endoscopic variceal ligation, polypectomies, stent placements therapeutic. EUS- EUS guided cystogastrostomy eus guided biliary drainage, eus coil embolization with glue Injection. EUS gastroenterostomy and advanced ERCP with cholangioscopy. Clinically, he is adept in managing conditions like inflammatory bowel disease, chronic liver diseases, GI bleeding, and motility disorders, performing advanced diagnostic and therapeutic interventions, and conducting esophageal and anorectal manometry. An enthusiastic educator, he actively presents cases, seminars, and lectures, mentors juniors, and participates in research and journal clubs. His numerous accolades include first prizes at ISNCON 2016 and TYSA West Zone Quiz 2019, a travel grant to WCOG 2019, gold medals in pathology, medicine, and surgery, and the Best Outgoing Student Award (2013).
